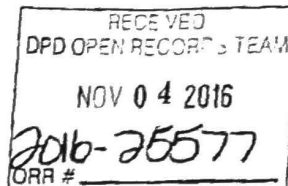

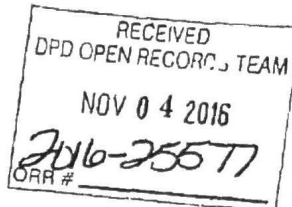

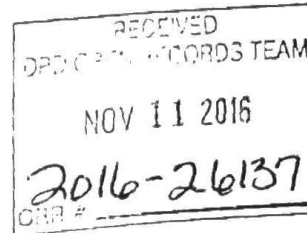

To whom it may concern:

This is a request under Texas Public Information Act, §6252-17a et seq. I hereby request disclosure of records including the following information related to each officer who fired shots in the 10/19/2016 fatal shooting of Anthony Garcia:

- Full legal name of officer (First, middle, last and suffix)
- Date of birth and/or age of officer
- Date of hire by police department
- Gender of officer
- Race of officer
- Officer's assignment at the time of shooting
- Whether the officer was injured during the incident, and if so, what injuries were sustained
- Whether the officer had fired shots in a previous fatal or non-fatal shooting
 - If yes, please provide dates of previous shootings and whether they were fatal or not
- Whether the officer has received commendations for on-duty work at the department
 - If yes, please provide dates of commendations and short descriptions of what they were for
- Whether the officer had any disciplinary action related to use-of-force or excessive force
 - If yes, please provide dates and details of disciplinary actions
- Whether the officer was flagged by any type of in-house Early Warning System prior to this fatal shooting
- Whether the officer was wearing a body-worn camera at the time of the incident
 - If yes, was the camera recording at the time of the incident?
- Whether the officer is a veteran of the U.S. armed forces, and if so, of what branch
- Whether the officer started their career in the department or came from another department

If you regard any of the requested records as subject to exemption from required disclosure under the law, I hereby request that you exercise your discretion and disclose them nonetheless.

If the reason you are unable to disclose information is that there is an ongoing investigation, please notify me and wait to fulfill the request until such time as the investigation closes.
