## Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

On Thursday, February 25, 2016, at approximately 10:39 a.m., East Side Patrol Officer E. Perez was dispatched to the 8511 Leander in regards to an Aggravated Assault with a Deadly Weapon. Upon arriving at the location, Officer Perez spoke to suspect Cody Harris's common-law wife, Ms. Gabriela Bautista, who advised him that Codey Harris had slapped her and threatened to shoot her with a gun. She said Harris grabbed his black revolver and said, "Bitch, I'll kill you. I don't give a fuck. I'll kill myself too!" Ms. Bautista continued and stated that she and the suspect's step-father, Mr. Modesto Aldavera, gathered her two young children and got in Mr. Aldavera's vehicle. According to Ms. Bautista, suspect Harris attempted to pull the kids out of the vehicle but was only able to twist her arm behind her. Ms. Bautista stated that they drove around the corner and then called the police. After obtaining Ms. Bautista's statement, Officer Perez located suspect Harris in the back yard of the location. Officer Perez attempted to make contact with

him, but suspect Harris ran into the house and barricade himself inside with his weapon. A perimeter was set up and SWAT and HNT were notified of a barricaded Suspect with a pistol. Upon arriving to the location, SWAT and HNT took control of the scene and proceeded with their investigation. HNT members made numerous attempts to convince suspect Harris to surrender but he refused to exit the house peacefully. Having obtained a written Consent to Search the premises earlier from the owner of the house, Mr. Modesto Aldavera, SWAT proceeded to make entry to the location. Upon making entry through the back door, SWAT members utilized a robot to search the interior of the house. Through the robot, SWAT members observed that the suspect had fallen through the ceiling in a bedroom while attempting to hide in the attic. SWAT members visually located the suspect hiding under a couch in the living room and once again established verbal communication with him. SWAT members made several attempts to convince suspect Harris to surrender peacefully, but all efforts were unsuccessful. While SWAT was in the kitchen and Harris was in the living room, Harris threatened to shoot the K-9 dog if it was sent into the living room. After several minutes of negotiations, SWAT members heard two gunshots from under the couch where the suspect was hiding. SWAT members proceeded to clear the couch and observed the suspect Harris with a self-inflicted gunshot wound to the head. The suspect was later found to have one gunshot wound to the head and the second fired round was discovered in the wall besides the suspect. The revolver in Harris's hand had two spent cartridge casings in it. Suspect Harris was immediately transported to Ben Taub Hospital where he was on life support and listed in very critical condition with a gunshot wound to the head. On Friday, February 26, 2016, the Houston Police Department Homicide Division was notified that the suspect had been pronounced dead at 1439 hours as a result of the self-inflicted gunshot wound to his head. Suspect Harris's criminal history includes a Possession of Marijuana in 6/11/2007, Possession of a Controlled Substance in 09/02/2008 in a drug free zone, Possession of a Controlled Substance in 06/13/2009, Possession of a Controlled Substance in 12/05/2013 and Driving while intoxicated in 03/08/2015. His criminal convictions and adjudications include, Possession of Marijuana, two Possessions of a Controlled Substance with one being in a drug free zone and one Driving While Intoxicated. Based on statements obtained from his immediate family members, suspect Harris had not been diagnosed with any mental disorders. The Mental Health Unit is being contacted and Codey Harris's mental health status check is pending.
