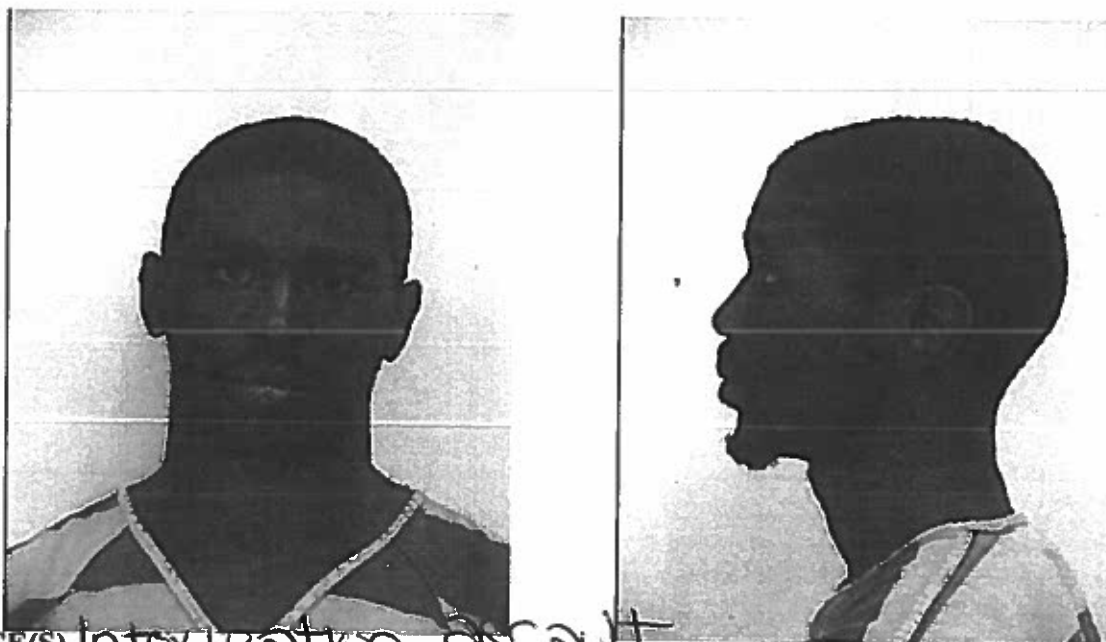

Inmate Titus was being disruptive during a mass movement out of Building 1 while in Edward Unit. Officers responded as he stood up walking towards the entry door upset and agitated. Officer Cornelius placed handcuffs on Inmate Titus on the wall next to the door in my presence. Inmate Titus was resisitive, but enough to be restrained on the wall.

Inmate was placed in the Emergency Restraint Chair (ERC) to prevent possible harm to himself (Continuously kicking and running his shoulder into the Holding Cell Door). Once he was in the ERC and had restraints checked by the nurse he was sent to Building 2 B Unit. He was compliant during the extraction from Holding 1 to the ERC. The inmate never made any complaints of any kind other than cursing at officers. Sgt. James was given the Protective Restraint Form and his officers took control of the ERC with Inmate Titus. I signed off the first hour of the restraint form.

On June 2nd , 2017, I, Officer K. Cornelius #5348 was assigned as a uniformed officer for the Travis County Correctional Complex (TCCC) Building 1 Search and Escort Officer, located at 3614 Bill Price Rd, Del Valle, TX 78617.

At approximately 1920 hours Officer Ortiz #5460 called for assistance in Edward unit with an inmate later identified as:

Titus, Herman  
BK# 17-19321 B/M  
D.O.B 08/06/1995

Inmate Titus was sitting on the floor and when the door was opened for responding officers he stood up and walked aggressively towards officers. I took control of inmate Titus's hands and walked him out of the unit. Inmate Titus became verbally aggressive and attempted to remove his hands from my control. I placed inmate Titus against the wall to secure his hands with handcuffs and he was placed in holding for safety. While Titus was in holding he began kicking the door and charging it with his shoulder. The decision was made to place inmate Titus in the (ERC) Emergency Restraint Chair. Officer Cordova#5411 and I instructed inmate Titus to lay prone on the floor so he could be restrained to which he complied. Titus was then secured in the chair without issue. Medical was called and the restraints were checked. Inmate Titus was taken to Building2 (12 Pending)

At approximately 1920 hours Officer Ortiz from E-unit requested for "one to be removed" via his radio. The inmate was later identified as:

When Officer Cornelius #5348 and I opened the unit door, Titus stood up from where he sat and began to walk towards Officer Cornelius while yelling and waving his arms. As Officer Cornelius attempted to take control of Titus and escort him to Building 1 Holding cell #1, Titus continued to resist and talk loudly. Titus was placed against the near by wall outside of Edward unit as Cornelius gained full control and placed inside of Holding 1. While in Holding 1, Titus kicked and would run his shoulder into the door. It was determined that Titus would be placed in the Emergency Restraint Chair (ERC). Officer Cornelius and I gave Titus the direction to lay face down to which he complied. Titus was placed in the ERC without incident. Medical was notified and sent a nurse to check the restraints. Titus was escorted to Building 2 (12 pending)

On 02 June, 2017 at approximately 1920 hours, I, Officer Ortiz while working as a uniformed corrections officer in Building 01 E unit located at the Travis County Correctional Complex (TCCC) at 3614 Bill Price Road, Del Valle, Texas 78617.

While in the process of unit move, an inmate identified through Tiburon as;

Titus, Herman

While moving 16 inmates out of E Unit to Building 12, Inmate Titus sat on the floor instead of the benches. I ordered inmate Titus to stand up and get ready to move. He told me, "No I'm not getting up!" I ordered Inmate Titus to get up one more time and inmate Titus continued to tell me, "No, I'm not getting up and go ahead and call the other officers." (MJ-Refusing to Follow a Written or Oral Directive) Inmate Titus was also inciting other inmates in the waiting line I called for the available search and escort duty officers to have Inmate Titus removed from the unit.

When Officers Cornelius #5348 and Cordova #5411 opened the E unit door inmate Titus immediately got up and became resistive towards the approaching officers (MJ-Threatening). The S&E Officers quickly secured the inmate by taking control of his arms and placing him against the wall. He began to curse at Officer Cornelius calling him "A Ho and Hoe Ass Law." (MJ-Disrespect to Staff) Inmate Titus was then taken in the holding cell to be secured.

While inside the holding cell the inmate became more disruptive and started to kick the door during inmate moves going to Building 12 (MJ-Disrupting Jail Activity). To prevent injury to himself, Inmate Titus was secured in an emergency restraint chair. Inmate Titus will be moving to building 02B 12B lockdown pending disciplinary. End of report.
